## Declaration

Pursuant to Clause I. 4. of the General Ruling of the City of Jena on the obligation to wear a face mask (extension) of 17 April 2020<sup>1</sup>, in conjunction with the Third Thuringian Regulation on necessary measures to contain the spread of the coronavirus SARS-CoV-2 (Third Thuringian SARS-CoV-2 Regulation on Containment Measures - 3rd ThürSARS-CoV-2-EindmaßnV0-), as well as the Thuringian Regulation on quarantine measures for arrivals and returnees in the fight against the coronavirus SARS-CoV-2<sup>2</sup>, the following regulations have been put in place for specific groups of people (persons at risk), which also apply to participants in examinations in enclosed spaces:

1. Persons who enter Thuringia by land, sea or air from a country outside the Federal Republic of Germany are obliged, immediately upon arrival, to go directly to their own residence or to other suitable accommodation and to self-isolate there for a period of 14 days after their entry into Thuringia; this also applies to persons who travelled first to another state of the Federal Republic of Germany.
2. Persons who are not residents of the City of Jena and who have had contact within the last 14 days with a person in whom a SARS-CoV-2 infection has been established in the laboratory, are forbidden from entering the location of their professional or other activity in Jena for a period of 14 days after the last contact.
3. Persons who within the last seven days have exhibited symptoms of illness (raised body temperature of over 37.5° C, a dry cough, breathing problems (shortness of breath), pain in the lungs, acute loss of the sense of smell and taste, severe sore throat, joint pains) or who continue to exhibit such symptoms (even if they have not been abroad and have not had any known contact with a person in whom a SARS-CoV-2 infection has been established in the laboratory) are forbidden from entering the location of their professional or other activity while the symptoms are present and for seven days after the symptoms have ended (unless a laboratory diagnosis excludes a SARS-CoV-2 infection).

With my signature I declare that I have taken note of the above regulations and that I do not fall under any of the three groups of cases mentioned:

**Data Protection Notice:** The FSU collects your details (matriculation number, signature) to fulfil the obligations arising from the two above-mentioned legal regulations. The data will be stored for the duration of the validity of the legal regulations. You have the possibility to assert the rights referred to in Articles 15-21, 77 GDPR.
